

MINUTES OF THE REGULAR MEETING OF THE PALISADE BOARD OF TRUSTEES October 12, 2021

The regular meeting of the Board of Trustees for the Town of Palisade was called to order at 6:00 pm by Mayor Greg Mikolai with Trustees present: Jamie Sommerville, Ellen Turner, Bill Carlson, Nicole Maxwell, and Mayor Pro-Tem Thea Chase. Trustee Susan L'Hommedieu was absent. A quorum was declared. Also in attendance were Town Manager Janet Hawkinson, Town Clerk Keli Frasier, Community Development Director Brian Rusche, Finance Director Travis Boyd, and Police Chief Deb Funston.

Town Finance Director Travis Boyd presented the Board with the draft 2022 budget.

Mayor Mikolai suggested the December meeting for the date for the public hearing to accept the final 2022 budget. The consensus of the Board is to hold a public hearing to accept the final budget for 2022 on December 14, 2021.

OPEN DISCUSSION

Mayor Pro-Tem Chase announced that she had been voted vice-chair of the Colorado Venture Capital Authority Board and requested an update on the progress of broadband. Trustee Turner stated that they would be doing a presentation at one of the next two meetings.

Trustee Carlson stated there was a new coffee shop next to Diorio's, that he attended the Palisade Fire Station open house over the weekend where he learned a lot, and that Rapid Creek Cycles' Palisade Plunge shuttles have been vandalized twice recently.

Mayor Mikolai stated that over 1200 people have been brought up to the Palisade Plunge so far this season.

Trustee Maxwell observed that she saw people in the grocery store parking lot drinking beer behind their van the previous Sunday.
