ADMINISTRATION COSTS

DEFERRED JUDGMENT: In all actions in which a defendant is granted a deferred judgment and sentence, the defendant <u>shall be assessed</u> a fee in the amount of **\$50.00**.

PROBATION: In all actions in which the Court orders a defendant to be placed on probation, the Court <u>shall assess</u> a fee of **\$50.00**.

BENCH WARRANT: In all actions in which a bench warrant is issued for the arrest of a defendant for failure to appear or failure to pay fines and costs ordered by the Court, the Court <u>shall assess</u> against said defendant a fee in the amount of **\$50.00** in addition to all other fees and costs due and owing.

OUTSTANDING JUDGMENT WARRANT: In all actions in which notice of an outstanding judgment or bench warrant is issued to the Colorado Department of Revenue, Division of Motor Vehicles, for a defendant for failure to appear, failure to pay fines or failure to otherwise perform as ordered, the Court <u>shall assess</u> against said defendant fee in the amount of **\$50.00** in addition to all other fees and costs due and owing.

VIOLATION TRAINING SURCHARGE: In addition to any docket fee or other costs imposed, a surcharge in the amount of **\$10.00** on each Municipal Court action resulting in a conviction, plea of guilty or no contest or in a deferred judgment and sentence <u>shall be levied</u>.

POLICE COMMUNICATION SURCHARGE: In addition to any docket fee or other costs imposed, a surcharge in the amount of **\$40.00** on each Municipal Court action resulting in a conviction, plea of guilty or no contest or in a deferred judgment and sentence <u>shall be levied</u>.

DOCKET FEE: If a conviction is imposed the docket fee <u>shall be levied</u> in the amount of **\$50.00**. A separate docket fee in the same amount shall be charged if a defendant is found guilty of a violation of probation, deferred sentence and judgment or contempt of Court.

PROSECUTION SURCHARGE: \$150.00 prosecution surcharge <u>shall be charged</u> to a defendant if a conviction is imposed following a trial to assist the Town in providing prosecution services. A separate prosecution surcharge in the same amount shall be charged if a defendant is found guilty of a violation of probation, deferred sentence and judgment or contempt of Court.
