

# MINUTES OF THE REGULAR MEETING OF THE PALISADE BOARD OF TRUSTEES March 25, 2025

The regular meeting of the Board of Trustees for the Town of Palisade was called to order at 6:00 pm by Mayor Greg Mikolai with Trustees present: Nicole Maxwell, Stan Harbaugh, Sarah Matchett, Rick Fox, and Mayor Pro-Tem Jamie Somerville. Trustee Jeff Snook was absent. A quorum was declared. Also in attendance were Town Manager Janet Hawkinson, Town Clerk Keli Frasier, Community Development Director Devan Aziz, and Parks, Events & Facilities Director Troy Ward.

### **AGENDA ADOPTION**

*Motion #1* by Mayor Pro-Tem Somerville, seconded by Trustee Harbaugh, to approve the agenda as presented.

### **PUBLIC HEARING I**

ORDINANCE 2025-01 A text amendment to section 7.05 of the Palisade Land Development Code concerning specific accessory use and structure standards.

Mayor Mikolai opened the public hearing at 6:07 pm.

Community Development Director Devan Aziz gave a brief presentation about the proposed text amendments.

Mayor Mikolai opened the hearing to public comment.

Dave Walker of Palisade applauded the Planner and Staff for the work on the proposed Ordinance; however, he still had issues with the two-foot setbacks.

The Board of Trustees discussed the proposed Ordinance at length, including the following topics:

- Easements

### **PUBLIC HEARING II**

ORDINANCE 2025-02 A text amendment to section 7.01 of the Palisade Land Development Code concerning short-term vacation rentals (STVRs).

Mayor Mikolai opened the public hearing at 6:36 pm.

Community Development Director Aziz gave a brief presentation about the proposed text amendments.

Mayor Mikolai opened the hearing to public comment.

JoAnn Rasmussen of Palisade supports what was presented but questions the wording of homeowners being required to be present during the rental period.

Jaida McKeever of Palisade commented that if a Palisade resident owns a second home in Palisade, that should be considered a local as well.

Michelle Walker of Palisade noted that STVRs should have to pay commercial property tax just like Bed & Breakfasts do.

Dave Walker of Palisade agreed that STVRs should have to pay commercial property tax and that municipalities have made owning an STVR so easy that no one wants to open a Bed & Breakfast anymore.

The Board of Trustees discussed the proposed Ordinance at length, including the following topics:

- All felt there was still more work to be done to complete the Ordinance

*Motion #5* by Trustee Matchett, second by Trustee Harbaugh, to adopt Resolution 2025-09 authorizing the Town Manager and Mayor to execute the documents necessary for property acquisition up to \$50,000 along the route of the Palisade to Clifton Sewer Transfer Project.


