

MINUTES OF THE REGULAR MEETING OF THE PALISADE BOARD OF TRUSTEES July 23, 2024

The regular meeting of the Board of Trustees for the Town of Palisade was called to order at 6:00 pm by Mayor Greg Mikolai with Trustees present: Sarah Matchett, Rick Fox, Stan Harbaugh, and Mayor Pro-Tem Jamie Somerville. TAP Grant (Sidewalks from Cresthaven to Palisade High School) Land Acquisition Contracts

Town Manager Hawkinson reviewed the staff report and clarified the process for moving forward on the project.

Motion #3 by Trustee Mastchett, seconded by Mayor Pro-Tem Somerville, to direct the Town Manager to enter into contract for the final purchase of right-of-way to complete the sidewalk project with a 20% grant match and no more than \$35,000 extra over the total cost.


ADJOURNMENT
