Consider Comment on BLM Grand Junction-Colorado River Valley Supplement Environmental Impact Statement on Oil and Gas Leasing

Town Manager Hawkinson introduced Scott Breaden, the director of the Colorado Wildlands Project, who reviewed the BLM Grand Junction-Colorado River Valley Supplement Environmental Impact Statement on Oil and Gas Leasing.

Mayor Mikolai allowed public comment on this item.

Chelsie Miera, the Director of the West Slope Colorado Oil and Gas Association, explained the improvements the oil and gas industry has accomplished regarding emissions while drilling and the regulations imposed on oil and gas drilling operations.

Board members discussed the content of the proposed letter, the importance of protecting the Palisade watershed, and the unknown content of the environmental impact study proposed alternatives.

Motion #4 by Trustee Somerville, seconded by Mayor Pro-Tem Turner, to approve the proposed letter commenting on the BLM Grand Junction-Colorado River Valley Supplement Environmental Impact Statement on Oil and Gas Leasing as written.
