CDOT will be paying for the construction of the roundabout to be installed at this intersection for the safety of drivers and pedestrians. CDOT has held public open houses with various design for public feedback last year. CDOT has concluded this design is the safest and best design for this intersection.

CDOT is paying for the construction of this project.

The Town of Palisade will be responsible for the landscaping of the roundabout and any artwork that might be placed on it as an entryway into the town.

### A RESOLUTION OF THE TOWN OF PALISADE, COLORADO, SUPPORTING COLORADO DEPARTMENT OF TRANSPORTATION CONSTRUCTING A ROUNDABOUT AT THE INTERSECTION OF HIGHWAY 6 AND ELBERTA AVENUE

WHEREAS, a roundabout is included in the Town of Palisade Comprehensive Plan; and

WHERERAS, professional traffic engineers have performed professional traffic studies that have determined this is the correct and safest design for this intersection; and

WHEREAS, the Colorado Department of Transportation has \$7,500,000 in state funding for the roundabout design, construction, and potential property acquisition.

**RE:** Purchase replacement truck for Public Works Department

#### **SUMMARY:**

The Public Works Department needs to replace a fleet pickup truck that is used in our wastewater treatment and collections. We would like to replace the 2002 Dodge Dakota. It is starting to have mechanical and body issues that are going to require larger investments in the truck over time. The cost of repairs and maintenance on the vehicle will soon exceed the value of the truck.

We allocated \$25,000 for the replacement of this truck in the 2024 Budget. We do not have a specific replacement truck selected at this time but would like to begin searching for a used vehicle.

Palisade Procurement Policy requires Board approval even if it is in the budget. Budgeted items still need to follow the policy. This request is for the Board to approve up to \$25K for staff to go find a truck, this is the approval needed to purchase a used truck. Staff is asking for approval now, so we don't have to wait until the next meeting to close the deal and leave a buyer hanging and have somebody else swoop in a buy it.

Town Code: Sec. 4-84. - Expenditure approval and source selection requirements.

#### **SUBJECT:**

Resolution 2024-03 supporting a grant from the US Bureau of Reclamation under the WaterSMART Small-Scale Water Efficiency Projects Grant.

#### **SUMMARY:**

The US Bureau of Reclamation is offering a Small Scale Water Efficiency Grants of up to \$100,000.00 for projects not to exceed \$225,000.00. The Town's match amount for this grant would be supplied through the Utilities Water Fund and would be \$118,000.00. This grant supports the Town's already established water meter upgrade project.

This funding opportunity is to invite States, Indian Tribes, irrigation districts, water districts and other water delivery authority to leverage their money and resources by cost sharing with the Reclamation on small-scale on the ground projects that seek to conserve, better manage, or otherwise make more efficient use of water supplies.

## TOWN OF PALISADE, COLORADO RESOLUTION NO. 2024-03

A RESOLUTION OF THE BOARD OF TRUSTEES FOR THE TOWN OF PALISADE, COLORADO, SUPPORTING THE GRANT APPLICATION FOR A 2024 SMALL-SCALE WATER EFFICIENCY PROJECT (SWEP) GRANT FROM THE US BUREAU OF RECLAMATION FOR UPDATES TO THE PALISADE WATER SYSTEM WATER METERS.

WHEREAS, the Town of Palisade is a political subdivision of the State of Colorado and, therefore, an eligible applicant for a grant awarded by the US Bureau of Reclamation; and

WHEREAS, the Town of Palisade has requested \$218,000 (\$100,000 from the US Bureau of Reclamation and \$118,000 match from the Town of Palisade) for updates to the Water Meter Replacement Project (the "Project") through the Small-Scale Water Efficiency Projects grant program (the "Grant"); and

WHEREAS, the Board of Trustees of the Town of Palisade supports the Grant application for the Project, and if the Grant is awarded, the Town of Palisade supports the completion of the Project.

## NOW, THEREFORE, BE IT RESOLVED THAT THE BOARD OF TRUSTEES FOR THE TOWN OF PALISADE, COLORADO, THAT:

- Section 1: The Board of Trustees of the Town of Palisade strongly supports the Grant application and has appropriated matching funds for a grant with the US Bureau of Reclamation.
- Section 2: If the Grant is awarded, the Board of Trustees of the Town of Palisade strongly supports the completion of the Project.
- Section 3: The Board of Trustees of the Town of Palisade authorizes the expenditure of funds necessary to meet the terms and obligations of any Grant awarded.
- Section 4: If the Grant is awarded, the Board of Trustees hereby authorizes the Mayor to sign the Grant agreement with the US Bureau of Reclamation.
- Section 5: This Resolution to be in full force and effect from and after its passage and approval
