Estimated Time-Line of on-going Projects & Grants:

June - August 2021

- 6. August 19 Peachfest Ice Cream Social hosted by the Town
- 7. Submitted application for \$100,000 Main Street Revitalization Grant for detached sidewalks on north side of Hwy 6 next to fire station.
- 8. Town engineers preparing RFP for asbestos & old high school removal. Scheduled to advertise mid-July.
- 9. Working with CDOT on lease agreement for land northeast of Highway 6 bridge the town will lease the area, remove tamarisk & Russian olive, create a boat ramp and small parking area. The area will stay native river bank.

PALISADE BOARD OF TRUSTEES Staff Report

Personnel and Training

We are completing a successful Fire Academy. Five individuals will be graduating and ready for what is being anticipated as a very high fire season.

Administration

The software programs Target Solutions and Check-It have been implemented. This provides online training for fire, medical and OSHA training to personnel. Target Solutions tracks initial and recertification requirements and allows us to develop agency specific training to be presented. Check-It tracks all inventory related items such as medical supplies, apparatus inventory, fire equipment, etc. This will provide increased controls and cost savings as we will be able to track how much we are actually using and order accordingly.

Working on the Colorado Resource Rate Form (CRRF) Agreement with staff. This will allow Palisade Fire Department to deploy personnel and equipment to wildfires or other such events throughout the State. Personnel have been working diligently to obtain the necessary qualifications and purchasing their own supplies in preparation for future opportunity. Under the CRRF Agreement the Town can bill for apparatus and personnel deployed. This provides personnel a means of making some more money while the Fire Department generates revenue.

Apparatus and Equipment

Ladder testing has been scheduled for September in conjunction with other area fire departments. Historically Clifton Fire has coordinated this with area fire departments to reduce the fees.

Working with crews from both Palisade Fire and Clifton Fire to coordinate the required annual pump testing for the fire apparatus. Clifton has all the necessary equipment and location for this.

The air cylinders for the cascade system are being hydrostatically tested. These are the storage cylinders that are for the compressor which was donated to Palisade Fire from East Orchard Mesa Fire after our 1987 unit had catastrophic failure. This donation saved the Town an estimated \$100,000 in costs for a new unit.

Ambulance 41 is out of service indefinitely due to an electrical issue that would require the entire unit be rewired. Due to its age, milage and previous maintenance costs it is not cost effective to the Town to attempt this level of repair. Upon Board direction at the June 8 meeting, the Town Manager and I are working on options for a replacement. In the meantime, Clifton Fire is loaning their reserve Ambulance to the Town for use.

In performing a basic risk assessment of the apparatus owned and operated by the Town of Palisade for the Fire Department, it is evident that most if not all apparatus has surpassed their point of return on investment. Several apparatuses have been sold due to either significant mechanical needs and/or safely concerns. Through forward thinking, the Town Board of Trustee's recognized a need and allocated \$150,000 towards a new water tender. The initial intention of using this as a match for a grant is good in theory. Unfortunately, even if we were successful in our application for grant funding, the build time is approximate 180 – 200 days (6 – 7 months) if not longer. We would not hear back on the grant until some time in September which would mean we would not take possession of the unit until at least March or April of 2022. Given the current and historical potential for local incidents there is a clear current need. It is my recommendation that we utilize the current budgeted funds of \$150,000 to purchase a viable used unit and put it in service sooner than later. While not guaranteed, it provides us with the opportunity to send it on local wildfire deployments to begin generating revenue in turn helps pay for itself while at the same time generating revenue which can then be reinvested into a realistic apparatus replacement program ultimately reducing legal liabilities on the Town of Palisade and increasing services to our community. The unit would have to have;

- 1800 2000 gallon water tank with a minimum of 250 gpm pump
- Single Rear Axle (so a CDL is not required)
- NFPA compliant water tank baffling

TOWN MANAGER REPORT

Town Manager Janet Hawkinson reviewed her report, focusing on aspects of the proposed *Palisade Bluegrass Bash* application and *grass in front of the Civic Center*.

The consensus of the Board was as follows:

- Approve the concert permits for the Palisade Bluegrass Bash events

PUBLIC HEARING I

PRO-2021-10 - Palisade Historical Society Sign Variance

Mayor Mikolai opened the public hearing at 6:38 pm.

Community Development Director Brian Rusche reviewed his staff report, explaining the requested variances.

The request is for a variance from Section 10.10.C of the Palisade Land Development Code (LDC) for a sign approximately 32 square feet set at the height of six (6) feet on the west property line of 3740 G Road (Parcel # 2937-093-39-001), as applied for by the Palisade Historical Society, pursuant to Section 4.12 of the LDC.

The proposed sign is four feet by eight feet (4' x 8') which is 32 square feet and would be mounted at the height of six feet (6') to the fence along the west property line to be seen from both directions of Highway 6.

- 1. There are exceptional conditions pertaining to the particular piece of property in question because of its shape, size, or topography that are not applicable to other lands or structures in the same district [or there is a peculiar characteristic of an establishment which makes the parking and/or loading requirements of this LDC unrealistic];
- 2. Granting the variance requested will not confer upon the applicant any special privileges that are denied to other residents of the district in which the property is located.

- 3. A literal interpretation of the provisions of the LDC would deprive the applicant of rights commonly enjoyed by other residents of the district in which the property is located.
- 4. The requested variance will be in harmony with the purpose and intent of this LDC and will not be injurious to the neighborhood or to the general welfare.
- 5. The special circumstances are not the result of the actions of the applicant.
- 6. The variance requested is the minimum variance that will make possible the legal use of the land, building, or structure. In approving a variance, the Board of Adjustment may prescribe reasonable and appropriate conditions which will ensure that the use will be compatible with adjacent properties and will not alter the character of the neighborhood.

The applicant submitted pictures of the property and other details about the request and the reasoning for the variance, along with a letter of support from the Palisade Pharmacy.

Priscilla Walker and Jamie Cox, representing the Palisade Historical Society, gave a brief presentation on the reasons behind their request. They also withdrew their request for the size variance requested, and the dimensions allowed in the Land Development Code are sufficient for their needs. Property owner Kirk Bunte also spoke in support of the request.

Mayor Mikolai opened the hearing to public comment. None was offered.

Mayor Mikolai opened the hearing to Board comment.

Town Manager Hawkinson requested that due to the non-profit status of the Palisade Historical Society, that the Board waive the required variance fees.

Mayor Pro-Tem Chase asked questions for clarification on the proposed variance.

SUBJECT:

2020 Supplemental Budget Appropriation for Conservation Trust Fund

SUMMARY:

The Conservation Trust Fund was established as a requirement to track the revenues and expenditures associated with the Colorado Lottery system. The lottery revenues are mandated to be used only for the acquisition, improvement, and maintenance of parks and open spaces.

In 2020, the board of trustees approved the use of \$60,000 from this fund toward parks improvements in the adopted budget.

In 2020, the playground equipment and park benches in Riverbend Park were approved by the board and funded from this fund. The expenditures are in accordance with the scope and restrictions of the Colorado Lottery system. Total expenditures in 2020 were \$63,747.45.

The board is being asked to officially amend the 2020 Conservation Trust Fund expenditure budget to \$63,747.45 from \$60,000.

The revenues received in this fund during 2020 total \$28,833.31. \$26,000 in revenues were recoded in the 2020 budget. The board is being asked to amend the 2020 budget to reflect the actual revenue received in 2020.

Re: Request for a Special Election to Sell Public Property, the Main Street

Bathroom, to be replaced by a "Boutique Hotel"

SUBJECT: The Town was approached on the concept of building a small 'boutique' hotel in our downtown area. Upon researching land use, zoning and needs, the location of the downtown restrooms at 209 Main Street was determined to be a great site for this small 'boutique' hotel.

About the Project:

The town staff is working on a new lease with the Union Pacific Railroad to obtain additional parking to the east of Main Street on both sides of the track. This will allow the town to offer additional parking to businesses and events as well as beautify the area and add wayfinding signs. In the 'historic' town center, parking is not required for development. However, a hotel needs parking for its guests. With a successful outcome, the leased parking on the southeast of Main Street can be utilized for the hotel parking. See map.

Price to sell the public restrooms will be determined by the appraised value of the property in 2021. New public restrooms in the downtown area can be developed, if the main street bathrooms are removed. There are various locations for a public restroom in this area. See map. Replacing the restrooms will not be a problem and will save the town costly renovation presently needed at the 209 Main Street restrooms.

Process:

For the Town to sell public property, it must go to the vote of the citizens of Palisade. As we do not have an election scheduled until April, an election to sell the bathroom property would need to be a 'special election' this fall. Please see the attachment on required notices, dates and timeline for a special election. Staff can perform this task, similar to past elections.

BOARD DIRECTION: Direct staff to bring a Resolution before the Board authorizing a special election, specifying ballot language and an election date.

Palisade Special Elections Process

Special Elections can be held on almost any Tuesday during the calendar year, except within 90 days preceding a regular Municipal Election.

Mail ballot elections vs. Polling Place Elections

In a **polling-place election**, one or more locations for voters to walk in and vote. Polling places are open from 7:00 am - 7:00 pm on election day only. The only mail-in ballots that can be accepted are official absentee ballots that have been requested in writing by a registered voter.

In a **mail-ballot election**, there are no polling places; however, there must be at least one mail ballot drop-off location for voters to drop off their ballots instead of mailing them. Ballots are mailed to all registered voters before election day. Before counting mail-in ballots, election judges must verify the signature on the back of the return envelope against the signatures in the voter registration database.

Mail Ballot Elections are what the Town of Palisade typically holds each election cycle.

Past Election Costs

- 2020 Non-Coordinated Mail Ballot Election \$10,627.11
- 2018 Coordinated Mail Ballot Election \$3,891.06
- 2016 Coordinated Mail Ballot Election \$4,811.00

The costs for ANY election may not be passed to anyone other than the Municipality holding the election.

Timeline for a Coordinated Special Election

The Board of Trustees must pass a Resolution authorizing a Special Election and the ballot language at a regularly scheduled meeting. Depending on how quickly the appraisal could be conducted, we could have a Resolution prepared for the Board meeting on July 13, 2021, or July 27, 2021, for approval. A coordinated election is generally the most cost-effective manner of holding an election.

It could be possible to coordinate with Mesa County in the November special election. The Town would have to enter into an IGA with Mesa County no later than July 23, 2021, if the Board decides to go that route. Price will be based on the number of ballots we need, as well as how many other agencies request coordinated elections. Currently, the Town of Palisade has 2,037 registered voters. In the IGA, it would be requested that Mesa County would take care of all printing, counting, and tabulating. Palisade would be responsible for verifying content for the ballot and verifying addresses on the registered voter's list as belonging in the Town of Palisade town limits. This is similar to past coordinated elections.

A coordinated election will not be until November, and the information would be distributed with another election. This might not provide the best public information for this project and would delay the developers from moving forward.

Timeline for a stand-alone special election

The Board of Trustees must pass a Resolution authorizing a Special Election and the ballot language at a regularly scheduled meeting. Depending on how quickly the appraisal could be conducted, we could have a Resolution prepared for the Board meeting on July 13, 2021, or July 27, 2021, for approval.

After speaking with the head of the Colorado Municipal Clerk Advisor Program through the Colorado Municipal League (CML), the estimated costs of elections are approximately \$4.00 per voter. That would put us at an estimated \$8,148.00. Most of the process would be done in-house, with ballot printing & mailing being done by an outside authorized company. Counting can be done by hand or possibly use another local municipality's ballot counting machine.

Ballot Process:

- Printing & Mailing Ballots: 3 4 weeks
- UOCAVA ballots must be mailed no less than 45 days before the day of the election.
- A list of active voters must be obtained no less than **30 days before the day of the election**.
- All other ballots may be mailed starting 22 days before the day of the election.

Possible Dates for a special election

- October 05, 2021 (UOCAVA ballots need to be mailed by August 20, 2021)
- October 12, 2021 (UOCAVA ballots need to be mailed by August 27, 2021)
- October 19, 2021 (UOCAVA ballots need to be mailed by September 3, 2021)
- October 26, 2021 (UOCAVA ballots need to be mailed by September 10, 2021)
- November 02, 2021, possibly coordinate with Mesa County
