Comments from the Fire Chief

We are over halfway through 2023 and have had a busy year with organizational changes and improvements. While we continue to struggle with consistency in staffing, I am grateful to our dedicated members. They have worked hard to help make the Palisade Fire Department a more desirable place to work and improved our reputation within the community. I am thankful to both the Town of Palisade Board of Trustees and the Palisade Rural Fire Protection Board of Directors for their ongoing support of the organization and their willingness to invest in the future of the organization.

<u>Administrative Update</u>

- Continuing to work on 2024 Budget Proposal with an emphasis on hiring three additional full-time employees and implementing a season wildfire program.
- Working on data collection and cost projections for potential mill levy increase for the Palisade Rural Fire Protection District.
- Attending weekly Fire Restriction Conference Calls With current conditions do not foresee going back into fire restrictions.
- Multiple Planning Meetings for Wine Festival
- Participated in Colorado State IMT Position Task Book Reviews
- Discussions with Town Administrator concerning ongoing lawsuit from 2019 concerning an ambulance sliding into another vehicle during inclement weather.
- Hosted the Mesa County Fire Chief's Meeting
- Attended the Colorado Department of Public Health's Ambulance Licensing Task Force meeting

Personnel Update

- Lieutenant Trevor Nieslanik successfully passed his National Registry Paramedic Testing and is currently working to get on Mesa County EMS Protocol
- Ongoing recruitment for part-time personnel

Apparatus/Equipment Update

- Ladder Testing was conducted on 8/12/23 with all passing.
- In-house Preventative Maintenance performed on Brush 41

Training Update

- I serve as the Chair for the Colorado Firefighters Academy. This will be the 35th year for this training event. CFFA is scheduled for September 28th through October 1st in Ignacio Colorado.
- Live Fire Testing/Training for our personnel and firefighters from East Orchard Mesa FD
- SCBA in-service training has begun.



Miscellaneous

- Grants submitted to Mesa County Federal Mineral Lease District for extrication and stabilization equipment. Board awards October 18th.
- Grant submitted to the Colorado Division of Fire Prevention and Control for eight sets of turnout gear and wildland PPE. Grant reviews take place in late September with notifications in October.
- Our annual department picnic was held at Peach Bowl Park on the 26th. This is a great time to come together as a family and to continue building a strong bond.
- The Palisade Fire Department brought home the trophy this year for the Guns & Hoses Tug-A-War.




Operations





Re: Powerload Gurneys

SUBJECT:

Purchase of two powerload gurney systems. One for each of the ambulances

SUMMARY:

Our gurneys have reached their point where they are beyond their return on investment. Due to their age, we can no longer get them serviced by a qualified technician creating liability issues. Our current gurney system requires personnel to lift and hold the gurney until the legs fully retract. This means a firefighter and/or two are forced to hold the weight of the gurney and the patient for an extended period.

A powerload gurney is a cot fastener system designed to help boost safety for patients and EMS providers by supporting the cot throughout loading and unloading. The reduction in spinal load helps prevent cumulative trauma injuries resulting in long term back injuries which is one of the leading causes for worker's compensation injuries for EMS personnel.

These powered stretchers do all the manual lifting, raising, and lowering. They can also load themselves into the unit when appropriately attached to the powered lift in the ambulance. They are rated to independently support up to 550lbs of weight without human assistance and 700lbs of patient weight overall.

Our newest ambulance was designed to eventually have this type of system integrated into the patient compartment. Our older ambulance requires a minor retrofit which is included in the project costs.

Why do we need them?

- Patient Safety reduces potential of dropping patients.
- Provider Safety Most common job-related injury is back injuries.
- Increased average weight 220lbs for males.
 - o Gurney 80 150 lbs.
- Higher weight capacity 700 pounds
- Small statured providers Half the department is female weighing 100 135lbs.
 - o Many are under 5'8" in height.
 - Often paired together.

Why now?

- Continuously rising costs October 1, 2023 5% price increase
- 4 consecutive years of unsuccessful grants applications
- Failing current gurneys old technology and worn out from use

Cost = \$110,000.00

- Includes
 - o Gurney
 - o Load System
 - o Installation Costs

SUBJECT:

The Board of Trustees for the Town of Palisade will consider supporting a grant application to be submitted by the Palisade Tourism Advisory Board (TAB) in partnership with the Palisade Chamber of Commerce for a Colorado Office of Economic Development and International Trade (OEDIT) Destination Tourism Marketing grant.

SUMMARY:

The Tourism Advisory Board, in partnership with the Palisade Chamber of Commerce, would like to apply for a Colorado Office of Economic Development and International Trade (OEDIT) Destination Tourism Marketing grant.

The grant is a 50/50 match for a total of \$40,000.00 to be divided as follows:

Palisade Chamber of Commerce:

10,000.00 investment + 10,000.00 grant = 20,000.00

Palisade Tourism Advisory Board:

10,000.00 investment + 10,000.00 grant = 20,000.00

The \$10,000.00 TAB wishes to expend was not budgeted for 2023, but is available in the Tourism Budget.

BOARD DIRECTION:

Approve supporting TAB applying for an OEDIT grant in partnership with the Palisade Chamber of Commerce for a destination tourism marketing grant, with \$10,000.00 being expended from the Tourism Fund.
