RE:	Resolution Authorizing Sewer Transfer Project Property Acquisitions

Under cover of this memo please find a resolution authorizing the acquisition and, if necessary, the condemnation of the properties necessary to accomplish the Palisade to Clifton Sewer Transfer Line Project (the "Project"). The Colorado Eminent Domain Statute, C.R.S. § 38-1-101 *et seq.* and the Uniform Relocation Assistance and Real Property Acquisition Policies, Act 42 U.S.C. 61, require that the Town follow a certain processes for the acquisition of any property interests necessary for the Project. The project engineer has identified the properties contained in the legal description exhibits to the Resolution as being necessary for the completion of the Project. These include temporary easements, permanent easements, and a fee simple (full ownership) tract for the lift station. As the Town's property acquisition consultant moves ahead with the process to acquire these properties this resolution will give staff and consultants the authority to negotiate and acquire the necessary properties. And should the Town and any owners not reach agreement on acquisition or the value of a property the Town Attorney will be authorized to initiate a judicial eminent domain proceeding in Mesa County District Court to acquire any property necessary to complete the Project.

TOWN OF PALISADE, COLORADO RESOLUTION NO. 2024-23

A RESOLUTION OF THE TOWN OF PALISADE, COLORADO AUTHORIZING THE VOLUNTARY ACQUISITION AND IF NECESSARY THE EXERCISE OF EMINENT DOMAIN POWERS TO ACQUIRE PROPERTY INTERESTS NECESSARY TO FACILITATE THE CONSTRUCTION OF THE PALISADE TO CLIFTON SEWER TRANSFER PROJECT.

WHEREAS, the Town of Palisade ("Palisade" or the "Town") is a statutory town organized pursuant to C.R.S. §31-1-203 and with the authority of the Municipal Code of the Town of Palisade (the "Code"); and

WHEREAS, the Environmental Protection Agency ("EPA") and the Colorado Department of Public Health ("CDPHE") have set new higher wastewater quality discharge standards which the Town's current systems do not meet; and

WHEREAS, the Town has an agreement with the Clifton Sanitation District to treat the Town's wastewater; and

WHEREAS, the Palisade to Clifton Sewer Transfer Project ("Project") is a necessary sewer connection within the Town and part of EPA and CDPHE standards; and

WHEREAS, the Town requires property acquisition including fee simple parcels, temporary easements, and permanent easements for the installation of the wastewater service pipelines; and

WHEREAS, the necessary property acquisitions are depicted in Exhibit A, as may be modified to accomplish the project goals; and

WHEREAS, Section 38-1-101 *et seq.* and 38-6-101 *et seq.*, C.R.S. provides procedures for municipal acquisition of property interests in private property where a public need is present, and specifically to "establish, construct, extend, open wide, or alter any street, lane avenue, boulevard, park, playground, parkway, pleasure way, public square, market viaduct, sewer, tunnel, or subway to build, acquire, construct, or establish any public building or any other public work or public improvement"; and

WHEREAS, pursuant to section 38-1-121, C.R.S. the Town has made or is in the process of making offers of fair market value, determined by land valuation experts, to the subject property owners for the acquisition of the property interests necessary to facilitate the Project; and

WHEREAS, the Town staff and negotiation consultants have determined that it may be necessary, if the Town and a property owner fail to agree upon compensation for a necessary property interest, for the Town to exercise its powers of eminent domain in order to acquire some of the remaining property interests necessary to facilitate the Project; and

WHEREAS, the Board of Trustees of Palisade, Colorado finds it is in the best interest of the health, welfare, and safety of citizens of the Town to authorize exercise of the Town's eminent domain powers in order to acquire all property interests necessary for facilitate the completion of the Palisade to Clifton Sewer Transfer Project.

NOW, THEREFORE IT IS RESOLVED THAT THE BOARD OF TRUSTEES OF THE TOWN OF PALISADE, COLORADO, THAT:

<u>Section 1</u>. The foregoing recitals are incorporated herein as if set forth in full.

<u>Section 2</u>. The Board of Trustees makes the following findings:

- i) The property interests depicted in **Exhibit A** will facilitate the construction of public improvements that are for public purposes and will provide uses and benefits to the community and its visitors, including but not limited to a higher standard of wastewater management.
- ii) The property interests depicted in **Exhibit A** are necessary to construct the Project.

<u>Section 3</u>. The Board of Trustees authorizes Town staff to initiate the voluntary acquisitions of the necessary property interests as depicted in **Exhibit A**, as may be modified to accomplish the project's goals, through negotiations with the respective property owners.

<u>Section 3</u>. Upon a determination that parties have failed to agree on compensation for the acquisition of a necessary property interest, the Board of Trustees authorizes the Town Attorney to initiate judicial condemnation actions under the Town's authority of eminent domain pursuant to C.R.S. §38-1-101 et seq. to acquire the remaining property interests necessary for the Project as expeditiously as possible.

SUMMARY:

CDOT has posted a Safe Routes to School Grant due this fall. This is an opportunity for the Town to apply for funding to assist with construction materials required by the Town to turn the frontage roads into multi-modal paths with the Highway 6 roundabout project. The grant funds will be used for construction materials: solar lights, reflectors, road dividers for bike/pedestrian and car lanes, and bollards. The route connects the town to both Palisade High School and Taylor Elementary.

WHEREAS, the Town of Palisade is requesting from the Colorado Department of Transportation for the construction of muti-use bike and pedestrian paths along Highway 6 (the "Project") through the Safe Routes to School Program Grant (the "Grant"); and

WHEREAS, the Board of Trustees of Town of Palisade supports the Grant application and if the Grant is awarded, the Town of Palisade supports the completion of the Project.

- Section 4: If the Grant is awarded, the Board of Trustees hereby authorizes the Mayor to sign the Grant agreement with the Colorado Department of Transportation.

SUBJECT:

Professional Installation of a Minisplit for Annex Building

SUMMARY:

In the winter of 2021 staff remodeled the south half of the old Annex building (former Firehouse) to create more office space. The heating and cooling for this space was never fully addressed and thus has experienced seasonal difficulties maintaining a comfortable office environment.

Three HVAC companies were contacted to offer solutions and provide quotes for the issue. It was determined that a Minisplit capable of handling the three separate office spaces was the best choice. The quote average was approximately \$20,000 to install and warranty the work.

Staff is recommending the professional installation of a Minisplit for the annex building for approximately \$20,000 with a 15% contingency (\$3,000) and not to exceed \$23,000. The project cost will come out of the facilities budget.
