• The month of June had 346 Calls for Service (CFS) (56 more than May). To date we have 1675 CFS. June usually marks the start of the busy months for Palisade Police Department and this month was no different. We scheduled and planned for Bluegrass and managed the needs of the town.

Grand Junction Communication Call Summary:

For the month of June 2023 Palisade Police Department calls for service are down 3%. The reduction in calls for service is a good sign for our community during the month of June. Year to date 2023 compared to Year-to-date 2022 we are down 10% on calls for service.

Investigations:


- Multiple cases are still being worked, to include abuse, fraud, assaults etc. These cases are complex and require multiple warrants and production of records to investigate. One serious caretaker abuse case is being investigated as well. This case is still ongoing and requires numerous hours of investigation.
- We are working to revamp our hiring practices to better find suitable candidates and meet state requirements. This is a slow and time-consuming process, and the hiring practices must be properly vetted prior to implementation.

Significant Events:

- We are now fully staffed and working towards continued growth and improvement. The officers we have are vigilant and working hard to address known complaints areas with traffic and other various issues to better our services.
- The Bluegrass Festival occurred, and the team was able to utilize new power bikes, metal detectors, and side by side to better offer services throughout the event.
- Officers assisted with a county wide traffic surge effort resulting in numerous tickets and stops around our area specifically I-70 from mile marker 42 to 46.

Message from Chief Jesse James Stanford:

Palisade Police Department staff have been focused on continued education with multiple services such as records, property and evidence, training, traffic enforcement, and most importantly finding new ways to build better communication with the public we serve. As we move forward in 2023 and gear up for Peach Festival, we are focused on public safety and creating a safe environment for all to enjoy. So I cannot say enough about the staff and all the hard work they are putting in day in and day out.



July Fire Chief's Report

For the month of June 2023, the Palisade Fire Department responded to 111 calls. This is an increase of 3 calls compared to this time last year. For the 2023 year to date we received 534 calls for service which is a decrease of 20 from 2022.

Apparatus/Equipment Update


- New digital medication safes have been installed in both Ambulances and in the station.

SUBJECT: ORDINANCE 2023-05 – AN ORDINANCE AMENDING THE LAND DEVELOPMENT CODE TO PROHIBIT SKILLED GAMING BUSINESSES IN ALL ZONES WITHIN THE TOWN.

SUMMARY: Throughout the Grand Valley, a new type of business known as *skilled gaming* has emerged. These businesses purport to offer *games of skill* that are distinguished from *games of chance*. However, these businesses look, feel, and operate much like casinos and use technology that complicates the investigation of these activities as illegal gambling. Unlike lawful gambling operations, allowed only in certain communities under the Colorado Constitution and regulated by the State, there are no regulations in place that protect consumers of skilled gaming from unscrupulous practices or regulations on the flow of money associated with these businesses.

State law has attempted to address this issue, starting with House Bill 15-1047, which bans *simulated gaming devices*, with the Legislature finding: "These machines, systems, and devices, as more fully described in this article, appear designed to evade the existing constitutional and statutory regulations on gambling activity in Colorado and therefore are declared to be contrary to the public policy of this state" (C.R.S. 18-10.5-101(1)(a)). The following amendment is proposed to Section 14.02 – Defined Terms, with words changes highlighted in **RED TEXT with new additions underlined and removals in strikethrough.**

Section 14.02 Defined Terms

Skilled Gaming Business means any business location which features slot machine(s), gambling device(s), simulated gambling device(s), or any mechanical, electrical, video, electronic or other device, contrivance or machine which after insertion or conveyance of a coin, debit card, credit card, cash, token or similar object or upon payment of any required consideration whatsoever by a player, is available to be played or operated, and which, whether by reason of the skill of the player or application of the element of chance, or both, may deliver or entitle the player operating the machine to receive monetary compensation and/or redeemable game credits, or any other thing of value.

This definition expressly includes 'fish game' 'fish game table' 'fish game gambling table' whoever denominated that consists of a tabletop electronic display with one or more stations featuring buttons, joysticks, or other control(s) that delivers to the player cash, cash premiums, redeemable game credits or any other thing of value for successful play, whether the redeemable payout is made from the machine, another machine, or from an employee of the business.

This definition expressly excludes any business location which features bona fide amusement devices that pay nothing of value, cannot be adjusted to pay anything of value, provide only unredeemable free games, or provide only tickets redeemable for nonmonetary prizes consisting of toys or novelties of nominal value, crane games, bingo operations, coin-operated music machines, or any bona fide amusement device authorized within restaurants by C.R.S. 44-3-103(47).

Slot Machine means any mechanical, electrical, video electronic, or other device, contrivance, or machine which, after insertion of a coin, token, or similar object, or upon payment of any required consideration whatsoever by a player, is available to be played or operated, and which, whether by reason of the skill of the player or application of the element of chance or both may deliver or entitle the player operating the machine to receive cash premiums, merchandise tokens, redeemable game credits, or any other thing of value other than unredeemable free games, whether the payoff is made automatically from the machines or in any other manner; except that the term does not include a crane game or vintage slot machine models introduced on the market in 1984, does not contain component parts manufactured in 1984 or thereafter, and is not used for gambling purposes or limited gaming purposes.

Gambling Devise means a device, machine, paraphernalia, or equipment that is used or usable in the playing phases of any professional gambling activity, whether that activity consists of gambling between persons or gambling by a person involving the playing of a machine, except that the term does not include a crane game.

Simulated Gambling Devise means a mechanically or electronically operated machine, network, system, program, or device that is used by an entrant and that displays simulated gambling displays on a screen or other mechanism, except that the term does not include bona fide amusement devices, as authorized in C.R.S. 44-3-103 (47), that pay nothing of value and cannot be adjusted to pay anything of value.

"Simulated gambling device" includes:

- a) Video poker game or any other kind of video card game;
- b) <u>Video bingo game;</u>
- c) <u>Video craps game;</u>
- d) Video keno game;
- e) Video lotto game;
- f) Video roulette game;
- g) <u>Pot-of-gold;</u>

- h) <u>Eight-liner;</u>
- i) <u>Video game based on or involving the random or chance matching of different pictures, words,</u> <u>numbers, or symbols;</u>
- j) An electronic gaming machine, including a personal computer of any size or configuration that performs any of the functions of an electronic gaming machine;
- k) <u>Slot machine, where results are determined by reason of the skill of the player or the application of the element of chance, or both, as provided by Section 9 (4)(c) of Article XVIII of the Colorado constitution; and</u>
- A device that functions as, or simulates the play of, a slot machine where results are determined by reason of the skill of the player or the application of the element of chance, or both as provided by Section 9 (4)(c) of Article XVIII of the Colorado constitution.

"Simulated gambling device" does not include any parimutuel totalizator equipment that is used for parimutuel wagering on live or simulcast racing events and that has been approved by the director of the division of racing events for entities authorized and licensed under Article 32 of Title 44 of Colorado Revised Statutes.

Crane Game means an amusement machine that, upon insertion of a coin, bill, token, or similar object, allows the player to use one or more buttons, joysticks, or other controls to maneuver a crane or claw over a nonmonetary prize, toy, or novelty, none of which shall have a cost to the arcade of more than twenty-five dollars per item, and then, using the crane or claw, to attempt to retrieve the prize, toy, or novelty for the player.

Section 4.01.E., Text Amendment Approval Criteria

In evaluating any proposed amendment of the text of the Land Development Code, the following shall be considered:

1. The extent to which the proposed text amendment is consistent with the remainder of the LDC, including, specifically, any purpose and intent statements;

The rise of skilled gaming businesses within the Grand Valley has created concerns about the circumvention of state law regarding regulated gambling and the increase in crime that results from these businesses.

2. The amendment must not adversely affect the public health, safety or general welfare;

The proposed text amendment would positively affect the public health, safety or general welfare.

3. The amendment is necessary because of changed or changing social values, new planning concepts or other social or economic conditions in the areas affected;

The proposed text amendment is necessary to address the societal ramifications of unauthorized, unregulated gambling.

4. The proposed text amendment revises the LDC to comply with state or federal statutes or case law; or

The proposed text amendment incorporates specific provisions of state law that already prohibit unauthorized, unregulated gambling.

5. The proposed text is found to be consistent with the Town's adopted comprehensive plan.

The recently adopted Palisade Game Plan contains the following Goals, Strategies, and Actions that are relevant to the discussion of appropriate land uses in Table 6.1:

Goal 2.1: Balance growth with preserving the agricultural heritage to maintain a sense of community.

Strategy 2.1B: Continue evaluating existing zoning regulations to determine if it promotes balance[d] growth with community preservation.

There are currently no skilled gaming businesses within the Town and the goal of the proposed text amendment is to ensure that remains the case.

RECOMMENDATION

The Planning Commission reviewed the proposed text amendment to the LDC and make a recommendation of approval, based on the above approval criteria, to the Board of Trustees.

WHEREAS, in accordance with Sections 3.02 and 4.01 of the Land Development Code, and Section 31-23-306, C.R.S., on July 18, 2023, a public hearing was held before the Planning Commission to consider a recommendation of an amendment of the Land Development Code to the Board of Trustees as set forth herein, following public notice as required by law; and

WHEREAS, in accordance with Sections 3.02 and 4.01 of the Land Development Code, and Section 31-23-304, C.R.S., on July 25, 2023, a public hearing was held before the Board of Trustees to consider the amendment of the Land Development Code as set forth herein, following public notice as required by law; and

WHEREAS, the Board of Trustees finds and determines that the amendments to the Land Development Code, as contained herein, are necessary and designed for the purpose of promoting the health, safety, convenience, order, prosperity, and welfare of the present and future inhabitants of the Town of Palisade and are consistent with the Town's Comprehensive Plan and the Town's other goals, policies and plans.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF PALISADE, COLORADO:

Section 14.02 Defined Terms

Skilled Gaming Business means any business location which features slot machine(s), gambling device(s), simulated gambling device(s), or any mechanical, electrical, video, electronic or other device, contrivance or machine which after insertion or conveyance of a coin, debit card, credit card, cash, token or similar object or upon payment of any required consideration whatsoever by a player, is available to be played or operated, and which, whether by reason of the skill of the player or application of the element of chance, or both, may deliver or entitle the player operating the machine to receive monetary compensation and/or redeemable game credits, or any other thing of value.

This definition expressly includes 'fish game' 'fish game table' 'fish game gambling table' whoever denominated that consists of a tabletop electronic display with one or more stations featuring buttons, joysticks, or other control(s) that delivers to the player cash, cash premiums, redeemable game credits or any other thing of value for successful play, whether the redeemable payout is made from the machine, another machine, or from an employee of the business.

This definition expressly excludes any business location which features bona fide amusement devices that pay nothing of value, cannot be adjusted to pay anything of value, provide only unredeemable free games, or provide only tickets redeemable for nonmonetary prizes consisting of toys or novelties of nominal value, crane games, bingo operations, coin-operated music machines, or any bona fide amusement device authorized within restaurants by C.R.S. 44-3-103(47).


<u>SUBJECT:</u> Sole source acquisition of lift station equipment for Troyer Lift Station

SUMMARY: The Town of Palisade plans to replace the sewage lift station located at Troyer Avenue. Not only is the lift station nearing the end of its functional lifecycle, but a recent expansion of its service area to include a large RV resort has increased the risk of costly service interruptions due to the lift stations' failure.

The Town has budgeted \$348,000 for the replacement of the sewer lift station complete project, \$174,000 from a DOLA Grant and \$174,000 from Town Funding. \$86,540.00 of the funds would be used to purchase a complete lift station package (equipment mechanical, equipment electrical and housing) from the Gorman-Rupp Company in a sole source purchase.

The Town's Engineer has worked with Town staff to recommend replacing the existing obsolete lift station equipment with a Gorman-Rupp 6'x 6' above ground lift station. The Town currently operates several Gorman-Rupp lift stations, and the utility employees are pleased with their dependability and ease of maintenance. Installing the same type of equipment within our infrastructure will simplify our parts requirements and service needs. Parts would be interchangeable, and employees are familiar with these systems, resulting in decreased costs of repair parts and service interruptions.

BOARD DIRECTION: The Board directs the Town Manager to enter into a sole source purchase contract to purchase the Gorman-Rupp Lift Station from The Gorman-Rupp Company.

The Town of Palisade plans to replace the sewage lift station located at Troyer Avenue. Not only is the current lift station nearing the end of its functional lifecycle, but a recent expansion of its service area to include a large RV resort has increased the risk of costly service interruptions due to failed components. The recommended replacement, a Gorman-Rupp 6'x6' above-ground lift station, offers the foremost reliability, long-lasting performance, and value.

Additionally, the Town of Palisade currently operates several Gorman-Rupp lift stations and the utility employees have attested to their dependability and ease of maintenance. Further homogenizing the infrastructure with the addition of another Gorman-Rupp unit would simplify the Town's parts and service needs. Parts would be interchangeable and utility employees would have universal familiarity with the lift stations, thereby decreasing costs and service interruptions.

NO OTHER WARRANTY, EXPRESS OR IMPLIED, INCLUDING ANY WARRANTY OR MERCHANTABILITY OR FITNESS, SHALL EXIST AS TO ANY EQUIPMENT OR GOODS COVERED HEREBY, ALL SUCH WARRANTIES BEING EXPRESSLY WAIVED BY THE PURCHASER.

The Company will, at its option, repair or replace any equipment or part which proves defective under its warranty provided that the purchaser notifies the Company in writing of such defect within the applicable warranty period and provided further that after start-up service has been performed, the labor to replace accessory items, such as sump pumps, dehumidifiers, relays or alternators, etc., shall be the responsibility of the owner's maintenance personnel. The foregoing states the purchaser's sole remedy for any breach of warranty by the Company.

PRICE ESCALATION CLAUSE:

Quoted prices are firm for fifteen (15) days subject to an escalation not to exceed 5% for the following sixty (60) days and 1-1/2% per month thereafter.

Orders accepted by The Gorman-Rupp Company will be held firm if the orders are approved and released for production within sixty (60) days provided shipment is accepted by the customer immediately following completion of production.

Orders accepted by The Gorman-Rupp Company where production release or shipment is delayed by the customer beyond (60) days following acceptance of order by The Gorman-Rupp Company, prices will be subject to an escalation not exceed 1-1/2% per month until again released.

Price escalation will not exceed Federal guidelines.

THE AMOUNT OF ANY APPLICABLE TAX or other Government charge upon the production, sales, shipment and/or use of the equipment covered by this quotation shall be added to the price and shall be paid by the purchaser.

ALL ORDERS SHALL BE MADE OUT toThe Gorman-Rupp Company; 600 South Airport Road; Mansfield, Ohio and shall be subject to acceptance by the Company. ORDER MAY BE CANCELED ONLY with the Company's written consent and ON TERMS that will indemnify the Company against loss. Cancellation fees shall be assessed in an amount equal to 50% of the Proposal/Contract amount after acceptance of the proposal for approval and/or purchaser receives submittal information; 100% of the Proposal/Contract amount after acceptance of the proposal for approval and/or verbal written approval release for production.

Performance of any contract by the Company shall be contingent upon credit approval, strikes, fires, accidents, war reduced supply of fuel or raw materials, or other restraints affecting shipments or curtailments in manufacturing or due to delays unavoidable or beyond the control of the Company.

THE COMPANY SHALL NOT, in any event, be liable for indirect, special, consequential or liquidated damages or penalties, whether based upon contract, warranty, tort or negligence.

When purchaser asks that equipment be warehoused or held for a stated or indefinite period after the equipment is ready for shipment, it is expressly understood and agreed that billing will be accepted as of the date when the equipment is ready for shipment and that STORAGE CHARGES (NOT TO EXCEED 1-1/2% PER MONTH) will apply thirty (30) days from that date.

Unless otherwise specified, DELIVERIES QUOTED are figured from the date of release to production. Statements as to expected shipment dates from the factory represent the Company's best judgment. Purchaser hereby waives all claim to damage caused by delay in shipment or delivery.

Unless otherwise specified, TERMS are Net 45 days from date of invoice, F.O.B., Mansfield, Ohio with freight allowed to the job site or first destination, whichever is applicable. All terms of credit are subject to the Company's approval and are independent of and not contingent upon the time and manner in which the purchaser may receive payment from others. Purchaser shall be notified of any changes in credit terms prior to acceptance of order.

ANY INDEBTEDNESS OWING TO THE COMPANY for a period longer than (30) days shall BEAR INTEREST until paid at the current prime rate. If the Company finds it necessary to place any indebtedness hereunder in the hands of an attorney for collection, purchaser shall pay all expenses and costs of collection, including reasonable attorney's fees.

THE PROVISIONS on the face hereof and these Terms and conditions constitute the entire agreement among the parties and supersede the provisions of any purchase order, other communication between the parties or any statement or representation not included herein. This Agreement may not be modified or amended except in writing signed by the parties intended to be bound thereby.

This Agreement shall be governed by the laws of the State of Ohio.
