No Official Action For The Town Of Palisade Will Be Conducted During This Work Session



EDA Roadmaps Mesa Grant Project:

Palisade, Fruita, Grand Junction, GJEP, Mesa County, and the Chamber of Commerce of each city has been awarded a regional planning grant. A separate attachment is included and posted on town website. This group is being led by a professional planning company, paid for by the grant. The starting planning document gives a great overview of regional data that is being utilized for this community planning project. It is called the Fruita Regional team because Fruita volunteered to manage the grant.

<u>Asbestos Remediation of the Old Palisade High School:</u> this project has begun and is scheduled to be completed end of December.

North River Road Widening: Part of the GOCO Grant for the construction of the Palisade Plunge Trail is the widening of North River Road from Highway 6 to 3rd Street. This project will be constructed in 2 phases and combined with an overlay project on the bridge. The first phase has started. Expect 10-15 minute delays as the contractor removes/ replaces material in preparation for asphalt.

Federal & State "Ear-Mark" Funding:

The Town of Palisade submitted a request for funding for \$800,000 for the design & engineering of the consolidation of sewer to Clifton Sanitation District. This project did make the request list and has been submitted by the State Senators for funding.

The Town has submitted a request for funding of \$1 M for the construction of a clinic. This project is on the request list submitted by the State Senators for funding. Announcement date is December.

Riverbend Park

Crews have painstakingly continued the Russian Olive and Tamarisk mitigation project along our river corridor. A significant amount of work has been accomplished toward site preparation over the past several months and years. It is exciting for Town staff to announce that the restorative phase of this multi-year and multi-agency project will begin at the end of this month.

In collaboration with our colleagues at RiversEgde West, we have put together a comprehensive list of trees, shrubs, perennials, and seed mixtures for this project. We have given special attention to the specific plants and seed mixes that benefit pollinators and the riparian inhabitants of the Colorado River corridor.

Through grants and grant match funding, yards of material, hundreds of potted plants and acres of seed have been sourced and purchased for this exciting next phase. Town staff, volunteers, and staff from RiversEdge West will all congregate on the 27th of October to plant and restore this crucial riparian habitat.

None of this would be possible if not for the continued support from the Palisade Board of Trustees, RiversEdge West, Western Colorado Conservation Corps, GOCO, CYCA, CPW, and of course the number of Town staff who have shed blood, sweat, and tears along the riverbank. In the coming months, take a stroll along the east end of the Riverfront trail to see the work that has been accomplished. Planting of potted plants should be completed by months end. We will be spreading the seed mixes over the fall, winter, and spring to provide the best opportunity for this vegetation to take hold and thrive. Next spring should be very exciting to see the new vegetation where before there was only invasive species choking the landscape.

Irrigation water will be turned off in the coming weeks. Crews will then winterize our parks and facilities. The Utilities Department has started preparation and scheduling for leaf pick up that will start in the coming weeks. The leaf material that is gathered during this process will be used in part for the Riverbend Park restorative project. This biomass material is a critical component to augmenting the soils of our park. In other areas of our parks, the leaves that fall from the trees are moved and mulched back into that environment.

Festivals and Events

The 2021 festival and Sunday market season is about wrapped up. There was a delayed start, but it turned out to be a successful year for event organizers as some experienced record attendance and participation. We look forward to next year and a full return of the Palisade event schedule.

Disc Golf

The Colorado Disc Golf State Championship will take place on October 23rd and 24th at the Palisade Disc Golf Course in Riverbend Park. Competitors from all over the State are coming to participate in this event. Riverbend Park will be closed to dogs and recreational walkers during the 2-day event. Spectators are welcome but must remain in the designated areas that are determined by the event organizers. Peach Bowl Park is the alternate dog park during the weekend.

Trick or Treat Street is planned for October 29th from 3pm to 6pm. The event is bringing back the fan favorite pet parade!

TOWN OF PALISADE, COLORADO ORDINANCE NO. 2021-11

AN ORDINANCE OF THE TOWN OF PALISADE, COLORADO, AMENDING CHAPTER 2, ARTICLE VIII OF THE PALISADE MUNICIPAL CODE REGARDING FIRE CHIEF RESIDENCY REQUIREMENTS.

WHEREAS, the Town of Palisade ("Palisade" or the "Town") is a Colorado municipality organized pursuant to Title 31 of the Colorado Revised Statutes and with the authority set forth therein; and

WHEREAS, Section 2-182(c) of Article VIII of Chapter 2 of the Palisade Municipal Code requires the Fire Chief of the Palisade Fire Department to establish residency within the Fire District within 3 months of promotion or hire; and

WHEREAS, the Town entered into an intergovernmental agreement with the Clifton Fire Protection District ("CFPD") for the sharing of fire service personnel and equipment whereby CFPD provides a Fire Chief and Deputy Chief for command over all personnel, including Palisade Fire Department personnel; and

WHEREAS, the Board of Trustees finds and determines that it is in the interest of the Town to amend the Palisade Municipal Code to account for the new organizational structure with CFPD.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF PALISADE, COLORADO THAT:

Section 1. The foregoing recitals are incorporated herein as if set forth in full.

Section 2-182(c) of Article VIII of Chapter 2 of the Palisade Municipal Code is hereby amended as follows, with <u>underlined text added</u> and strike through language deleted:

Sec. 2-182. Sec. 2-182. - Fire Department organization.

(c) The Fire Chief shall be appointed by the Town Administrator by an appropriate selection process established by the Town Administrator. The Fire Chief shall establish residency within the Fire District within three (3) months of promotion or hire.

Re: Approved de-activation of water service and monthly fee

SUBJECT: This is a memo to inform the Board of a water account de-activation to 2 empty lots. No decision needs to be made by the Board.

The Town of Palisade entered into an agreement to extend water service in the Vinelands to 3 lots. The owners of the lots paid for installation, and it was agreed that the owners also purchase the water taps at this time, so the fees would not be lost in the future. One owner was ready to use the water. The other 2 lots are vacant and not ready to use the water.

One lot has a house and is using the water and paying the monthly service charges.

The other customer owns 2 lots with no homes and is not using any water. The owner brought the water to the lots and paid for the taps for future construction of homes.

The owner with 2 empty lots has requested not to pay the monthly water bill as they have not used any water, the water has never been turned on, and is turned off at the valve.

The code states that once the water tap is paid, an account is created and the customer is billed. This is an out-of-town water service agreement. The town code does not address this situation. Because the customer has not used any water, the line has not been activated and the water is turned off at the valve, and the town had the owner pay the tap fees with the installation of the line so they would not get overlooked in the future, the customer is not being charged the monthly water fees. This is fair to the customer and the account will be activated once the water is turned on at the valve and water is being used.
