**A RESOLUTION OF THE BOARD OF TRUSTEES FOR THE TOWN OF PALISADE,
COLORADO, SETTING TIME, PLACE, AND DESIGNATED POSTING LOCATION
FOR PUBLIC MEETINGS FOR THE TOWN OF PALISADE, COLORADO.**

WHEREAS, in accordance with 24-6-401 and 402 (2) C.R.S., the Board of Trustees of the Town of Palisade wishes to comply in spirit and in fact with the Colorado Open Meetings Law;

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Town of Palisade, Colorado, that;

Section 1.

(a) The Board of Trustees shall meet for regular meetings at 6:00 pm on the second and fourth Tuesday of each month, excluding November, which shall have one regularly scheduled meeting on the first Tuesday of the month, and December, which shall have one regularly scheduled meeting on the second Tuesday of the month. Regular meetings may begin at 7:00 pm if a work session is scheduled.

(b) The Board of Trustees shall hold regularly scheduled meetings in the Board Chambers located at the Palisade Civic Center, 341 West 7th Street.

(c) The Board of Trustees shall hold work sessions as needed at 6:00 pm on the second and/or fourth Tuesday of each month.

(d) The Board of Trustees shall hold any scheduled work sessions in the Training Room located at the Palisade Civic Center, 341 West 7th Street.

(e) The Board of Trustee meetings are to end by 9:00 pm unless a motion is made to extend the meeting.

Section 2.

(a) The Planning Commission shall meet at 6:00 pm on the first and third Tuesday of each month, excluding November, which shall have one regularly scheduled meeting on the third Tuesday of the month, and December, which shall have one regularly scheduled meeting on the first Tuesday of the month.

(b) The Planning Commission shall hold meetings at the Board Chambers located at the Palisade Civic Center, 341 West 7th Street.

(c) The Planning Commission meetings are to end by 9:00 pm unless a motion is made to extend the meeting.

Section 3.

(a) The Tourism Advisory Board shall meet monthly at 9:00 am on the third Wednesday of every month at the Palisade Civic Center, 341 West 7th Street.

(b) The Tourism Advisory Board shall hold meetings at the Board Chambers

located at the Palisade Civic Center, 341 West 7th Street.

Section 4.

Standing Committees shall meet as needed, and a notice of these meetings shall be posted in the designated posting location.

Section 5.

The designated posting location for the Palisade Municipal Government shall be the bulletin board outside the vestibule of the Palisade Municipal Building, 175 East 3rd Street, Palisade, Colorado, and other locations as determined by the Town Administrator.



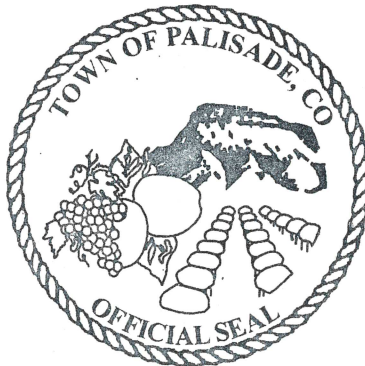
