A RESOLUTION OF THE BOARD OF TRUSTEES FOR THE TOWN OF PALISADE, COLORADO, SUPPORTING THE GRANT APPLICATION FOR A 2025 AARP COMMUNITY CHALLENGE GRANT FOR A COMMUNITY WELLNESS SAUNA

WHEREAS, the Town of Palisade is a political subdivision of the State of Colorado and, therefore, an eligible applicant for a grant awarded by the American Association of Retired Persons (AARP); and

WHEREAS, the Town of Palisade has submitted an application for the establishment of a Community Wellness Sauna (the "Project") through the AARP Community Challenge Grant program (the "Grant") for a total of \$20,000 with a matching contribution from the Town of Palisade not to exceed \$20,000; and

WHEREAS, the Town of Palisade certifies that the Project meets the eligibility requirements of the AARP Community Challenge Grant program by creating a vibrant public place that will serve all residents especially those age 50 and older, establish permanent physical improvements in the community, and introduce new, innovative programming; and

WHEREAS, the Board of Trustees of the Town of Palisade supports the Grant application for the Project, and if the Grant is awarded, the Town of Palisade supports the completion of the Project.

NOW, THEREFORE, BE IT RESOLVED THAT THE BOARD OF TRUSTEES FOR THE TOWN OF PALISADE, COLORADO, THAT:

- Section 1: The Board of Trustees of the Town of Palisade strongly supports the Grant application for the Community Wellness Sauna Project with the AARP Community Challenge Grant program and has appropriated matching funds not to exceed \$20,000 for the Project.
- Section 2: The Community Wellness Sauna Project will establish a new quality of life-improving amenity at the community swimming pool that provides multiple health benefits for residents, creates a social hub to combat isolation, and promotes overall well-being through evidence-based health interventions.
- Section 3: The Board of Trustees of the Town of Palisade authorizes the expenditure of funds necessary to meet the terms and obligations of any Grant awarded.
- Section 4: If the Grant is awarded, the Board of Trustees hereby authorizes the Mayor to sign the Grant agreement with AARP.
