**A RESOLUTION OF THE BOARD OF TRUSTEES FOR THE TOWN OF PALISADE,  
COLORADO, SETTING TIME, PLACE, AND DESIGNATED POSTING LOCATION  
FOR PUBLIC MEETINGS FOR THE TOWN OF PALISADE, COLORADO.**

**WHEREAS**, in accordance with 24-6-401 and 402 (2) C.R.S., the Board of Trustees of the Town of Palisade wishes to comply in spirit and in fact with the Colorado Open Meetings Law;

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Trustees of the Town of Palisade, Colorado, that;

**Section 1.**

(a) The Board of Trustees shall meet for regular meetings at 6:00 pm on the second and fourth Tuesdays of each month, excluding November and December, which shall each have one regularly scheduled meeting on the second Tuesday of the month.

(b) The Board of Trustees shall hold work sessions as needed at 6:00 pm on the second and/or fourth Tuesday of each month.

(c) Regular meetings may begin at 7:00 pm if a work session is scheduled prior to the meeting.

(d) The Board of Trustees shall hold regularly scheduled meetings in the Board Chambers located at the Palisade Civic Center, 341 West 7th Street.

(e) The Board of Trustees shall hold any scheduled work sessions in the Training Room located at the Palisade Civic Center, 341 West 7th Street.

(f) The Board of Trustees meetings are to end by 9:00 pm unless a motion is made to extend the meeting.

**Section 2.**

(a) The Planning Commission shall meet at 6:00 pm on the first and third Tuesdays of each month, excluding December, which shall have one regularly scheduled meeting on the first Tuesday of the month.

(b) The Planning Commission shall hold meetings at the Board Chambers located at the Palisade Civic Center, 341 West 7th Street.

(c) The Planning Commission shall hold work sessions as needed at 6:00 pm on the second and/or fourth Tuesday of each month.

(d) The Planning Commission shall hold any scheduled work sessions in the Training Room located at the Palisade Civic Center, 341 West 7th Street.

(e) The Planning Commission meetings are to end by 9:00 pm unless a motion is made to extend the meeting.

**Section 3.**

(a) The Tourism Advisory Commission shall meet monthly at 9:00 am on the third Wednesday of every month at the Palisade Civic Center, 341 West 7th Street.

(b) The Tourism Advisory Commission shall hold meetings at the Board Chambers located at the Palisade Civic Center, 341 West 7th Street.

**Section 4.**


Standing Committees shall meet as needed, and a notice of these meetings shall be posted in the designated posting location.
